

Bust the Bill Stack

Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Bust the Bill Stack (the "Instant Win Game") is open only to legal residents of the fifty (50) United States, the District of Columbia, and Puerto Rico who are at least eighteen (18) years old at the time of entry. Void where prohibited. Employees, officers and representatives of Digital Insight, doing business as Intuit Financial Services (the "Sponsor"), Dailey, ePrize, LLC, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Instant Win Game is subject to all applicable federal, state and local laws and regulations. Discover Game Pieces on Your Financial Institution's Internet Banking Website: During the Promotion Period, visit your financial institution's Internet Banking Website (the "Website") to locate and click on any of the five (5) key icons ("Game Pieces") randomly placed throughout the Website. After clicking on a Game Piece, you will be advanced to the Instant Win Game website. Once on the Instant Win Game website, follow the links and instructions to complete and submit the registration form. Once you submit the form, follow the directions to advance to the Instant Win Game page and play the Instant Win Game. For each unique Game Piece you click on, you will receive one (1) Instant Win Game play.

b. Alternate Method of Entry: To obtain an Instant Win Game play without locating a Game Piece, visit <https://bustthebillstack.com/alternate> to complete the "Alternate Method of Entry" registration form. Once you submit the form you will receive one (1) Instant Win Game play. Follow the directions to advance to the Instant Win Game page and play the Instant Win Game.

The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game. Limit: Each entrant may play up to five (5) times by any method or combination of methods of entry per day. The first four (4) times you play the Instant Win Game in a given day (a day is defined as the period of time beginning at 12:00 a.m. PT and ending at 11:59 p.m. PT on the same calendar day), you will be eligible to win the First Prize. 1. Eligible Online Bill Pay enrollment and bill payments for the Promotion must be received and processed between June 15, 2010 at 12:01 a.m. PT and July 31, 2010 at 11:59 p.m. PT. Enrollments and bill payments processed after July 31, 2010 at 11:59 p.m. PT will not be eligible for this offer. 2. One Credit of \$10.00 will apply per eligible End User regardless of the number of End User owned eligible and active checking accounts with Online Bill Pay.
3. A \$10.00 credit will be deposited into End User's eligible checking account on or about September 15, 2010. For End Users with multiple checking accounts used for online bill pay with the participating Financial Institution, the Credit will be deposited into one of your active accounts with Online Bill Pay.
4. Enrollments made under multiple identities or through the use of any agent or other device or artifice to participate multiple times in violation of these Terms and Conditions will be deemed invalid.
5. Credits will not be given to End Users who do not meet these Terms and Conditions and that do not pay seven (7) online bill payments through the Sponsor's Online Bill Pay service during the Promotion Period.
6. Recipient of the Credit is deemed to be the End User whose name appears on the Online Bill Pay registration. A third party vendor will be used by Intuit to facilitate the deposit of the Credit. Our contracts with third party vendors outline the appropriate use and handling of your information and prohibit third parties from using any of your personal information for purposes unrelated to the product or service for which they've been contracted. Vendors are required to maintain the confidentiality of the information we provide to them.

5. ALL POTENTIAL WINNING PLAYS ARE SUBJECT TO VERIFICATION BY SPONSOR OR ADMINISTRATOR, WHOSE DECISIONS ARE FINAL AND BINDING. For the First Prize there will be five (5) random, computer-generated winning times per day during the Promotion Period. Release: By receipt of any prize, winner agrees to release and hold harmless Sponsor, Dailey, ePrize, LLC, and any promotional partners, each of their parent, subsidiary, affiliate and related companies, and each of its and their respective officers, directors, employees, and agents (collectively the "Released Parties") from and against any losses, damages, rights, claim or cause of action of any kind arising, in whole or in part, directly or indirectly, out of participation in the Instant Win Game or resulting directly or indirectly, from acceptance, possession, use, or misuse of any prize awarded in connection with the Instant Win Game, including

without limitation personal injury, death, and/or property damage, as well as claims based on publicity rights, defamation, and/or invasion of privacy.

Disputes: Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Instant Win Game or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (ii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Instant Win Game but in no event attorneys' fees; and (iii) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
